The main purpose of OHADA is unification and updating of business law to provide juridical and judicial security for economic activity in its member-states.

To date in OHADA 10 Uniform Acts (fr. l'Acte Uniforme) have been adopted that cover three categories of enterprises regulation:

 commercial activity, includes uniform acts on general commercial law, organizing securities, on contracts for carriage of goods by roads,

 registration and accounting of commercial enterprises, includes uniform acts on commercial companies and Economic Interest Groups – EIG, on Cooperatives, on the organization and harmonization of accounting and Accounting Law and Financial Reporting;

 settlement of commercial disputes and collection of trade receivables, includes uniform acts on arbitration law, on Simplified Debt Collection Procedures and Enforcement Proceedings, on bankruptcy proceedings, on Mediation.
